## Holocaust Today's precept for Total Transparency



The dedication of Holocaust Today to the proposition of veracity also implies the policy for the Total Transparency. All kinds of Holocaust Today's correspondence with the U.N. International Criminal Court, U.N. Civil Court of Justice, (i.e. letters, e mails, follow-ups, responses, statements, depositions) -irrespective of their content- will be made open to the public; available in all the languages around the world, whatsoever, as well as correspondence to all humanitarian, philanthropic, civil justice, vigilant think tank organizations of justice, democracy, national watchdogs, dignitaries, security, and also any defense organization and other United Nation's organization, but not limited to, the Secretary General, U.N. Ambassadors of every member and none member states, addresses to the United Nations General Assembly, Security Council, U.N. organizations i.e. UNESCO, WHO, ILO, WTO, WBG, IMF. Holocaust Today's Total Transparency also applies to any other international institution, e.g. NATO, EU, G8, G20, Nobel Peace Prize laureates, high clergy of all religions, specifically the three Abrahamic religions, as well the national institutions, e.g. U.S. Congressional Caucuses, Congressional Committees in House and Senate, correspondences to the Office of the President, the Department of Justice, DOD, CIA, NSA, FBI, DOC, Federal Reserve, etc. and to the Supreme Court, media, publications, op-ed in addition, whosoever relevant, pertinent or associated with the litigations, prosecutorial proceedings, judicial and the juridical proceeding in connection with the AustroGerm's Special Treatment.

Committed to the dedication for the Veracity, Holocaust Today pronounces the Total Transparency in all the international and national phases throughout the litigations against the AustroGerm's regimes, as well the prosecution of AustroGerm's criminals, felons, complicit elements, collaborators, lobbyists, co-conspirators, criminal strategists, abettors, suspects, and every participating, maintaining, supporting individual or organization working in cahoots with AustroGerm's elements -exempt the Guardian states- collectively termed as, "AustroGerm's Criminals," who are marshaled in the Schädling List, pronounced [ˈʃɛːtlɪŋ]; (List of Daredevils; Vermin List).
